

TERMS AND CONDITIONS

Effective as of 10/26/2018

1. GENERAL ACCEPTANCE

PressOnDemand LLC owns and operates the PressOnDemand app and corresponding website. This document governs your relationship with PressOnDemand LLC, its app, and website. Access to and use of this App/website and the products and services available through this app/website (collectively, the "Services") are subject to the following terms, conditions and notices (the "Terms of Service"). Note:
